The NPS is currently negotiating to have an information office in Fairbanks, and sometime this summer we ought to be able to go to this office and do as

PROPOSED REGULATIONS FOR NATIONAL PARKS AND MONUMENTS AND WILDLIFE REFUGES:

The National Park Service is distributing proposed regulations for National Parks and Monuments in the January 19, 1981 Federal Register. Regulations for Wildlife Refuges are being distributed in the same Federal Register by the U.S. Fish and Wildlife Service. Interested individuals can get copies of the part dealing with National Parks and Monuments from the Alaska Regional Director, National Park Service, 540 West 5th Avenue, Anchorage, Alaska 99501(phone: 907-271-4196). Copies dealing with the Wildlife Refuges can be obtained from Red Shelton, Manager of the Yukon Flats National Wildlife Monument, Room 266, Federal Building, Fairbanks, Alaska 99701(phone 452-1951, Ext. 250. Comments on both sets of regulations must be received by March 5.

#### DENALI NATIONAL PARK REGULATIONS:

Denali National Park refers to the extended boundaries of the National Park containing Mt. McKinley as defined by the d-2 legislation; McKinley Park refers to the pre-d-2 McKinley Park boundaries. Apparently there are some differences in the regulations for the expanded boundaries and those for the old McKinley Park. Regulations in the new Denali National Park tend to be more liberal.

On Feb. 12, the Alaskan Alpine Club(the other club)met with Bob Cunningham, Denali National Park Superintendent, to discuss park regulations as they impinged climbing. The issues discussed included the requirement that climbers register for Mt. McKinley and Mt. Foraker(one is not required to register for any other peaks), the requirement that climbers carry backcountry permits specifying the dates and areas of the park they will be allowed to camp when going to the mountains, and the criteria for selecting the people who would run the guiding concessions. Mr. Cunningham seems willing to allow climbers to pass through areas requiring backcountry permits without these permits if they are travelling to camp spots outside the permit areas. Mr. Cunningham seems very willing to consider the views of climbers concerning these issues. PROPOSED AMENDMENTS FOR THE ARTICLES OF INCORPORATION

Article III (Membership) 1st paragraph

"Family membership fees shall be ten dollars per year, from date of payment." to "paid by 1 September of each year".

Article V(Officers and Administration)

Keep or drop the third paragraph:

"With the purpose of maintaining the safety margin necessary for mountaineering in the remoteness and severe climate of Alaskan mountain areas, the Executive Committee shall review and approve the itinerary of each proposed climb and the qualifications of the leader and members of the party.

Write in a method for making the ex-President into a Counsellor.

Create paragraph 11

Version 1:

The Expedition Fund shall be established to permit the awarding of climbing grants. The monies of this Fund can be appropriated from the General Fund or donations may be added to it. Only the interest or the gains of the Expedition Fund shall be awarded; the capital will not be distributed, but will be managed by the Executive Committee so as to produce an income. The Executive Committee plus two Club members of 3 years standing shall disperse the Climbing Grants. If surplus money remains after awarding Climbing grants, the Expedition Committee may award funds for mountain rescue.

Version 2:

The Expedition Fund shall be established to permit the awarding of climbing grants. The monies for this Fund can be appropriated from the General Fund or donations may be added to it. The Executive Committee plus two Club members of 3 years standing shall disperse the Climbing Grants. If surplus money remains after awarding climbing grants, the Expedition Committee may use part or all of the remainder to award funds for mountain rescue.

COMING EVENTS (??)

An exhibit, "The Mapping of Denali", is now being shown at the University of Alaska-Fairbanks Museum until the end of April. Museum personnel are attempting to arrange to have Art Davidson, author of Minus 148 (an account of the 1967 winter climb of Denali), come to Fairbanks to talk on the exhibit. Keep a watch out for this.

All-woman Annapurna Climb. The ASUA has tentatively arranged to have Christy Tews, member of the 1979 Annapurna climb, give a slide show on the 12th of April at 8 PM in the Concert Hall on the U of A campus. They anticipate charging \$2.00. Remember this is tentative, so one should check later in the spring.

Dear Sir or Madam:

On November 25, 1980, revised regulations for mountaineering within Mount McKinley National Park were printed in the Federal Register. The revised regulations will continue to require registration with the Mountaineering Ranger for all persons climbing on Mount McKinley and Mount Foraker. However, the revision deletes two other sections of the regulations which were in effect before this date.

The requirement that all climbers submit a signed physician's certificate is no longer in effect. The requirement of this statement has not shown to be of benefit in reducing or eliminating accidents on Mount McKinley or Mount Foraker. As in the past, the importance of excellent physical condition will be stressed to all climbers, and expeditions will be urged to obtain medical advice during the planning of their trips.

The second portion of the regulations to be deleted is the requirement that all climbing parties on Mount McKinley and Mount Foraker carry a two-way radio. While radio communications are still an advisable precaution for any climbing party, the presence of a greater number of climbers and ready availability of Citizens' Band radios makes a regulated precaution requiring radio communications unnecessary. Most climbing parties now carry Citizens' Band radios which provide communications between expeditions, and communications with the Kahiltna Base Camp radio provided and staffed by the Talkeetna glacier pilots. Citizens' Band radios also provide communications with the glacier pilots' aircraft as they fly around the peaks.

Expeditions on Mount McKinley and Mount Foraker must register in advance by contacting the Mountaineering Ranger who will provide registration forms and helpful information. Expeditions can check in and check out with the Climbing Rangers at McKinley Park or Talkeetna (by phone or in person). These procedures are recommended for all other climbs within the Park.

The revised regulation as printed in the Federal Register states:

36 CFR 7.44(d) Mountain Climbing. Registration is required in advance on a form provided by the Superintendent for climbing Mount McKinley and Mount Foraker.
